## Brief Synopsis

Mr Dunning's lecture will look at the latest legal developments in relation to the Court's jurisdiction, powers and approach in considering applications for injunctive relief in relation to arbitration. Apart from discussing recent English cases he will also look at the position under the framework of various institutional rules.

## The Speaker

**Graham Dunning QC** is a specialist in international and commercial law, based at Essex Court Chambers in London. He appears in the High Court and the Appellate Courts and has recently won an appeal to the Privy Council from the Isle of Man. He took Silk in 2001 and is a Bencher of Lincoln's Inn.

Graham is heavily involved in international arbitrations as counsel and arbitrator. He has substantial experience in arbitrations of all types as counsel (ad hoc, LCIA, ICC, SCC, ICSID, UNCITRAL, LME, RSA, LCA, LMAA, AAA) in places such as London, Hong-Kong, Copenhagen, Moscow, Dubai, Geneva and Stockholm. He is also often appointed as an arbitrator. Over 35 arbitration appointments have been accepted, including disputes concerning commercial

and investment agreements; insurance contracts; oil and gas projects; construction and engineering; commodity trading; transport and shipping. He sat on a major LCIA arbitration concerning a Malaysian oil and gas engineering project, chaired an SCC arbitration in Sweden; and sat on two Geneva-seated arbitral tribunals.

Graham is a Member of the Singapore International Arbitration Centre Panel of Arbitrators, with an office in Maxwell Chambers Singapore and a Member of the Kuala Lumpur Regional Centre for Arbitration's Panel of Arbitrators.
